## **Reports (5-10 minutes per item)**

### 7. Program Pathways – *Bill Simpson*

Some programs have changed from one area of interest to another to help implement the IPaSS (Integrated Planning and Support for Students) and Start Right programs.

Program maps need to be reviewed and the team needs technology to manage this. The team proposes that each area review their program maps during the annual unit planning process.

Questions/concerns:

- Associates Degree for Transfer and Transfer Model Curriculum requirements change over time, so it would be good to have someone who is familiar with those changes assisting with maps.
- Maps are hard to find. Go to a program (like Accounting) that has a map and click on “Get a Roadmap!”
- When curriculum gets updated in Socrates, can we get it automatically updated in the maps? The person who was working on this is now working at the district office, so progress on this issue is at a stand-still.
- English would like to be able crosslist creative writing with Arts.
- As the areas of interest are developed, it is important to have faculty involvement--from student services and from instructional areas.

## ***Discussion (10-15 minutes per item)***

### 11. Report Back:

#### a. Responses to District 2+2 degree with Arizona State (ASU)

A senator recommended that the college build in some process for review of the agreement with ASU.

Several additional concerns and questions were expressed:

- 1) Throughout the application process, what information about criminal history is asked of applicants?
- 2) What portion of ASU's online college program involves for-profit components?
- 3) How might the CSUs and UCs perceive this type of partnership? How might the public/taxpayers perceive a collaboration with an out-of-state college--especially a state with values that are VERY different to California's?
- 4) Why are all 4 of our Los Rios Colleges listed as partners before a vote of the academic senate?
- 5) Why are we choosing to formally partner and send resources to a state and state university (Arizona) that discriminates against undocumented individuals? This decision gives the optics that we don't care about undocumented students or the policies that impact their lives.
- 6) What documentation can ASU provide that outlines the cost per unit for undocumented individuals? On the website, it indicates that undocumented students pay 150% of the tuition cost, which would make it more expensive to attend than if they stayed in state.
- 7) Will undocumented students be able to use their California Dream Act to pay for tuition?
- 8) What does ASU do to silo and protect the information of undocumented students, so as not to put them or their families at risk of harm?
- 9) Any of our students can choose to go to ASU now, we have the articulation agreements, why do we need to partner?
- 10) Given the equity gaps we are working to close and issues with accessibility, why are we rushing to create a new program?

#### b. Responses to syllabi guidance documents

- Are deans expected to honor this document? Yes.
- The syllabus is a contract, but it should be noted that it can be modified and students will be notified.
- Should how students acquire accommodations be in the "must" area of the guidance?
- Perhaps SLOs should not be included in the "must" area of the guidance. Since the

accreditation process requires that syllabi include SLOs, the “must” area seems appropriate.

- Do references to resources/support services like Veterans Resources, DSPS, Umoja, etc belong in a syllabus or in a separate “resources” document or area?

## 12. Report Out: District Academic Senate

### a. Implementation of District Faculty Hiring Manual

We do not know the criteria by which a committee will be determined to be representative of our service area (as determined by race and gender). We do not know who will be notified if a committee does not meet the criteria. We do not know how any change will be communicated (for example “Your committee does not meet the requirements--try again” vs “Your committee needs a Latinx member”). We do not know how whomever is notified is going to address the issue (find a member to add/replace). We do not know the timeline for when a committee might find out if the membership is not representative.

The Academic Senate directs the ARC Academic Senate President Alisa Shubb to find out the answers to these unknowns.

Concern: There may be an undue burden on faculty of color being called on to serve more often.

### b. Finals schedule availability at time of enrollment

The district senate has directed the LRCCD District Senate President Gary Aguilar to pursue this.

### c. Accessibility Task Force recommendations:

- i. To what extent should accessibility be faculty responsibility?
- ii. Can universal design encroach on teaching methodology?
