Senators suggested a statement similar to other governance documents which establishes primary and purview of the Academic Senate (on 10 + 1) and Title V regulations.

- 13. Report Out: District Academic Senate (DAS)
  - a. Changes to District Hiring Manual

Jennifer Laflam reported on the work of the District Faculty Hiring Manual Committee (a committee of the the District Academic Senate).

The manual is revised every three years. This year the committee's goal was to improve disparate impact on students by whom we hire and how. They looked at demographic data on students and faculty and determined that our departmental demographics don't reflect our student body.

The most significant changes were made to the following sections:

Sec. 7--Interview Committee-the new manual will advise departments to create screening committees which reflect the demographic make-up of the students body. This may mean that some departments will look outside their departments for committee members.

Sec. 8--Screening--the new manual explains equity-minded conceptions of "merit" and "fitness" for position

Sec. 9--Procedure

Hiring the Best trainings will be changed to reflect the hiring manual changes.

Senators asked how committees would be determined to reflect the demographics of the student body and who would decide/oversee this process?

Jennifer answered that the Academic Senate President and the Equity officer would work together to do so. Follow-up question: How do they work together now?

Gary Aguilar reported that thought this is the first time our Senate is reviewing the manual, Sac City has already approved it and it has already been seen by Los Rios counsel J.P. Sherry.

After asking for consensus from Senators, it was determined that at the next DAS meeting, the ARC Senate leadership would not support suspending the rules to fasttrack a vote on this document, and that we would possibly discuss the issue more at our spring retreat.

b. Los Rios Online Consortium

This will have a faculty weighted steering committee.

c. Update: Collegial Consultation

There has been more collegial consultation with the State Chancellor.
