*PMED 146 <u>Prehospital Trauma Life Support</u> (New to District)

Many health care agencies and many local Emergency Medical Services (EMS) organizations require PHTLS course completion as a requirement for initial paramedic accreditation, employment, or continued employment. PHTLS is a recognized standard in prehospital trauma education and is appropriate for emergency medical technicians (EMTs), paramedics, nurses, physician assistants, physicians, and other prehospital providers. PHTLS is accredited by CAPCE and recognized by NREMT. The course is applicable to students currently enrolled in the Paramedic (PMED) program or counts towards continuing education for those currently licensed.

ARC is hoping to imitate the success that community colleges in the Bay area and South state have had becoming Red Hat academies.
