- 2) Consider creating fliers to promote discussion.
  - *a)* Farlow mentioned location and role changes
  - *b*) Johnson suggested controversy promotes interest. Organize around an issue to get more people involved.
  - *c)* Talbott suggested a speaker for info, updates on construction and pathways, mentioned managers should get involved.
  - *d*) DeCosta shared a concern, we don't want to be the place for complaints, consider asking constituents what makes them want to attend meetings.
